#### The LCMS and COVID-19 Vaccines: Facts and Considerations

#### **COVID-19 Vaccines and Abortion**

- Reliable information on the sourcing and testing of COVID-19 vaccines from the pro-life researchers of the Charlotte Lozier Institute may be found at *lozierinstitute.org/update-covid-19vaccine-candidates-and-abortion-derived-cell-lines/*.
- According to the Lozier Institute, the current FDA-approved COVID-19 vaccines (Pfizer/BioNTech and Moderna) do not use aborted human fetal tissue in the design, development or production of the vaccines.<sup>1 2</sup>
- The current FDA-approved COVID-19 vaccines have been *tested* using human fetal cell lines (as are many other medicines, such as the MMR and polio vaccines, as well as treatments for HIV, Parkinson's and diabetes), but the vaccines themselves do not contain any aborted fetal cells.<sup>3</sup>
- Many remaining COVID-19 vaccines in development do use human fetal cell lines and are therefore considered "ethically controversial" (for instance, the UK-approved Oxford/AstraZeneca vaccine as well as the one from Janssen/Johnson & Johnson).

#### COVID-19 Vaccines and the Synod

- The Synod in convention has repeatedly adopted resolutions supporting the sanctity of human life and opposing abortion (e.g., 2019 Resolution 3-02A, 2010 Resolution 6-02A, 2007 Resolution 6-02, 2004 Resolution 6-04).
- The Synod in convention has not officially adopted a resolution concerning the use of vaccines developed from or tested using fetal cell lines.
- The absence of an official Synod stance does not impact an individual's ability to seek a religious or personal belief exemption from vaccine requirements. In many states, religious exemptions from vaccine requirements can be obtained by individuals on the basis of conscientious objection.
- Complete consensus does not exist in the pro-life community at-large on the reception of vaccines developed from or tested using fetal cell lines (e.g., the debates within Roman Catholic circles).<sup>4</sup>
- The Commission on Theology and Church Relations has published no report or opinion on vaccines. It has discussed the possibility of addressing it pursuant to 2019 Resolution 11-01A ("To Give Guidance and Encourage Action on Beginning-of-Life Issues"), but work on that has not begun.

#### What We Can Say

- The Synod remains steadfastly committed to the sanctity of human life and supportive of those institutions and individuals advocating for the unborn.
- Genuine concerns for life exist on both sides of the COVID-19 vaccination question: concern for the use of aborted fetal cells in the design, development, production and testing of vaccines, as well as concern for the physical well-being of one's neighbor endangered by the virus.
- There is no official Synod position on the use of COVID-19 vaccines (as such positions are ordinarily expressed through a resolution of the Synod in convention).
- Christians should respect the consciences of one another on a question where Scripture and the Synod have not spoken expressly.
- Members of the Synod and Synod congregations are encouraged to:
  - Educate themselves about the vaccines:
    - Consult with trusted health care providers, clergy and those who may be impacted by their decision; and
  - Act on the basis of informed conscience as to receiving the vaccine.

The Ladies Aid will be taking donations for the Easter lilies and we will also pick up the palms for Palm Sunday.





God's Law "Refreshing the Soul"

During a Bible study at our Spring District Conference on March 8-9, we reflected on how the Psalmist describes God's Law as perfect and "refreshing the soul." He later exclaims, "Oh! How I love your law!" (Ps. 19:7; 119:97, NIV). If you're like me, you struggle with this at first glance; how can any of us stand up and feel "refreshed" by God's law with all of its holy demands? Doesn't the law always accuse us (lex semper accusat is the well-known Latin phrase)? Answer: When we attempt to justify ourselves by the law, it certainly does and will always accuse! St. Paul says it best: "No one will be declared righteous in God's sight by the works of the law; rather, through the law we become conscious of our sin" (Rom. 3:20). Remembering Yessenia's comment from last month's newsletter, let's not offend Jesus by trying to impress God with our good works as if His were not enough!



Thanks be to God, Jesus has freed all of us from the <u>curse</u> of <u>not</u> fulfilling His law! In His atoning sacrifice Jesus says to you, "I have taken your curse upon myself. I have paid the whole punishment with my blood. My Father's wrath toward you is gone now. You are freed and innocent

and cleansed of your guilt and shame!"

Now, because the <u>curse</u> of the law is gone, we are free to <u>begin</u> to fulfill God's law as new creatures by the power of His Spirit dwelling in us—always <u>imperfectly</u> this side of heaven, and yet, always covered by Jesus' blood! As our Lutheran Confessions state it:

We believe, teach, and confess that, although people who truly believe in Christ and are genuinely converted to God have been liberated and set free from the curse and compulsion of the law through Christ, they indeed are not for that reason without the law. Instead, they have been redeemed by the Son of God so that they may practice the law day and night (Ps. 119:1]). For our first parents did not live without the law even before the fall. This law of God was written into the heart, for they were created in the image of God (The Epitome of the Formula of Concord, VI, 2).

The reason all of this comes to my mind is that I am witnessing the "refreshing" aspect of our Lord's law as I interact with people who are new to the faith. Liberated from the weight and guilt of the law upon hearing the good news of their *complete* forgiveness in Jesus, these people are finding that living according to their Creator's design is quite "refreshing" after years of utter lawlessness and chaos. Just as keeping the rules of a sport's game *allows* one to *enjoy* the game, it turns out that living according to our Creator's rules *allow* one to enjoy life more! Freed in Christ, God's good, holy, law is indeed **refreshing to the soul!**
